Direct Deposit of IRS Funds

Direct Deposit is a safe, reliable, and convenient way to receive Federal payments. The Department of the Treasury's Bureau of the Fiscal Service and the Internal Revenue Service both encourage direct deposit of IRS tax refunds. Direct Deposit combined with IRS e-file provides taxpayers with the fastest and safest way to receive refunds. You can direct your refund to any of your checking or savings accounts, but you cannot direct your refund to someone else's account, except for your spouse's account, if this is a joint account. No more than three electronic refunds can be directly deposited into a single financial account or pre-paid debit card. Taxpayers who exceed the limit will receive an IRS notice and a paper refund. Upon awareness of a Tax Refund deposit to an account that the recipient of the deposit does not have direct access to, we may return that deposit to the IRS without notification.
